A special meeting of the Plainfield Charter Township Board was held on August 23, 2010 at 7:00 PM in the Township Board Room located in the Township Offices located at 6161 Belmont NE, Belmont, Michigan 49306. Members in attendance: Supervisor Meek, Clerk Harvey, Treasurer Stover, Trustees Hagedorn, Matthews and Weldon. Trustee Borek ~~was~~ arrived at 7:05 PM. Also in attendance was Superintendent Robert Homan.

1. Supervisor Meek called the meeting to order at 7:00 PM and informed all in attendance that this is special meeting being held to consider approving the submittal for the Urban Farmers Market Grant being offered by the Michigan Economic Development Corporation as requested by Scott Harvey, Plainfield Charter Township Clerk.
2. Mr. Harvey presented to the Board ~~an~~ ~~complete~~ explanation of the grant request. 4. Supervisor Meek opened the floor to Citizens Comment's. Mr. Steve Besser spoke in favor of the Farmers' Market and wanted to thank the Plainfield Township Fire Department for the expert professional services they provided at the automobile accident he was involved in last week. Mrs. Ruth Ann Karnes shared concern about a child at the market asking people to come to her booth to buy vegetables.
5. Supervisor Meek adjourned the meeting at 8:15 PM.
