LICENSING ORDINANCE #475

CHAPTER X

SNOWPLOWING

Section 10.01. **LICENSE REQUIRED.** No person shall engage in the business of moving, removing or plowing snow upon public or private property within the Township without first having obtained a license therefore.

Section 10.02. **LICENSE APPLICATION.** Any person desiring to secure a license hereunder shall file an application for the same with the Township Clerk on forms to be provided by the Clerk. Said application shall contain the full name of the applicant, address and telephone number, and the make, model, VIN number and license plate number of all vehicles, which are to be used in the operation of, said business.

Section 10.03. **INSURANCE.** Each licensee shall, before commencing business, furnish to the Clerk, copies of policies of insurance evidencing the following insurance coverage: Property Damage - \$10,000 for each vehicle; and Public Liability - \$25,000 / \$50,000 for each vehicle.

Section 10.04. **SPECIAL EQUIPMENT.** In addition to all equipment and lighting required by the statutes of the State of Michigan or by any other Section of this ordinance, any vehicle licensed hereunder shall be equipped with a flashing, oscillating, or rotating amber light placed in such position as to be visible throughout 360 degrees. Said light shall be operated at all times that the vehicle is being used to move, remove, or plow snow.

Section 10.05. **PLACEMENT OF SNOW.** No licensee shall place, deposit, dump, or push any snow or ice upon or across any public right-of-way within the Township or upon any private property without prior consent of the owner.

Section 10.06. **EXEMPTIONS.** Dump trucks or other vehicles used exclusively for the hauling of snow shall be exempt from the licensing provisions of this Chapter provided such vehicles are not equipped with a plow, scraper, or blade.
